

# FANTASY FLIGHT GAMES USA A GAME OF THRONES BOARD GAME 10<sup>TH</sup> ANNIVERSARY GIVEAWAY OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK, TWITTER, OR INSTAGRAM.

1. **HOW TO ENTER:** The Fantasy Flight Games *A Game of Thrones: The Board Game* 10<sup>th</sup> Anniversary Giveaway Sweepstakes (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 12:00:00 PM (CT) on November 23, 2021 and ends at 11:59 PM (CT) on November 28, 2021 (this is the “Promotion Period”). To enter, eligible entrants must leave a comment of their favorite *A Song of Ice and Fire* character on the announcement post for this giveaway on Facebook, Twitter, or Instagram, and like FFG’s page on that respective site.

All Entries become the property of Sponsor. Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook account status, email address, and/or telephone number of entrants.

2. **PRIZE(S):** One (1) lucky winner will receive an *A Game of Thrones* prize package, the contents of which are listed below:

3. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of Facebook/Twitter/Instagram (whichever platform they use to enter). Employees of Fantasy Flight Games (“FFG”), its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “Promotion Entities”) and their immediate family members and/or those living in the same household of each are not eligible to participate. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48)

hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected.
