HOW TO ENTER: The **Fantasy Flight Games Aconyte Books Sweepstakes** (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 12:00:00 PM (CT) on 1/11/2021 and ends at 11:59:00 PM (CT) on 1/18/2021 (this is the “**Promotion Period**”). To enter, eligible entrants need only to share which is their favorite FFG book or story in a comment on the Facebook post for this Sweepstakes (“**Entry**”).

All Entries become the property of Fantasy Flight Games (“**FFG**”). Limit one (1) Entry per quiz question per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities may be disqualified from participation in this and future Sweepstakes and all Entries from that individual may be considered void. Proof of submission will not be deemed to be proof of receipt by FFG. FFG is not responsible for any change of Facebook account status, email address, and/or telephone number of entrants.

ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry and who are registered members of Facebook. Employees of Fantasy Flight Games, its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “**Promotion Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited.

WINNER SELECTION: Two (2) winners will be selected in a random drawing to be conducted on or about 1/19/2021, from among all eligible Entries received during the Promotion Period by the judges in this Sweepstakes, whose decisions are final and binding.

WINNER NOTIFICATION: Potential prize winner(s) will be notified initially by a private message to their Facebook account or a tag in the winner announcement Facebook post. FFG shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected. FFG, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.
