

FANTASY FLIGHT GAMES USA FACEBOOK SWEEPSTAKES 22 OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK, INC.

1. HOW TO ENTER: The Fantasy Flight Games Quiz Facebook Sweepstakes (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 12:00:00 PM (CT) on October 5, 2021 and ends at 11:59 PM (CT) on October 12, 2021 (this is the “Promotion Period”). To enter, eligible entrants must comment on the Sweepstakes Facebook announcement post their answer to the week’s quiz question (“Entry”).

All Entries become the property of Sponsor. Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook account status, email address, and/or telephone number of entrants.

3. ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of Facebook. Employees of Fantasy Flight Games (“FFG”), its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “Promotion Entities”) and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited. No Entry may contain the image or images of any minor(s).

5. WINNER NOTIFICATION: Potential prize winner(s) will be notified initially by private message to their Facebook account. Sponsor shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected. Sponsor, in its sole discretion, will attempt to contact up to four (4) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. In the event of a dispute about the identity of the entrant, Entries will be declared made by the authorized account holder of the email address associated with the social media account on which the Entry is made. An "*authorized account holder*" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide ANA with proof that a potential winner is the authorized account holder of the account associated with the winning Entry.
