

FFG Memory Twitter Sweepstakes

What are the Prizes?

Official Rules

HOW TO ENTER: The **Fantasy Flight Games Memory Twitter Sweepstakes** (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 12:00:00 PM (CT) on 09/25/2020 and ends at 12:00:00 PM (CT) on 10/02/2020 (this is the “**Promotion Period**”). To enter, eligible entrants must post a tweet sharing their favorite *KeyForge*-related memory and include the hashtag #FFGMemory in the post.

All entries become the property of Fantasy Flight Games (“FFG”). Limit one (1) entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Twitter accounts, or under multiple identities will be disqualified from participation in this and future Sweepstakes and all entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by FFG. FFG is not responsible for any change of Twitter account status, email address, and/or telephone number of entrants.

ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry and who are registered members of Twitter. Employees of Fantasy Flight Games, its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “**Promotion Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected. FFG, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed.
