

# **FANTASY FLIGHT GAMES USA SOCIAL MEDIA 12 DAYS OF GIVEAWAYS SWEEPSTAKES**

## **OFFICIAL RULES**

ALL FEDERAL, LOCAL, STATE, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED. NO PURCHASE NECESSARY TO ENTER OR WIN. YOU MUST HAVE INTERNET ACCESS TO ENTER. SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH META PLATFORMS, INC. dba META OR BLUESKY SOCIAL.

1. **ELIGIBILITY:** The Fantasy Flight Games (“FFG”) USA Social Media 12 Days of Giveaways Sweepstakes, (the “Sweepstakes”) is only open to legal residents of the fifty (50) United States and the District of Columbia who are at least eighteen (18) years old at the time of entry. Employees of Asmodee North America, Inc.
