

# **FANTASY FLIGHT GAMES USA LITERACY DAY ACONYTE BOOKS SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER. SWEEPSTAKES IS IN NO WAY SPONSORED, ENDORSED, ADMINISTERED BY, OR ASSOCIATED WITH FACEBOOK, INC.

1. **HOW TO ENTER:** The Fantasy Flight Games 2021 Literacy Day Aconyte Books Facebook Sweepstakes (“Sweepstakes”) is an online-only Sweepstakes. Sweepstakes begins at 12:00:00 PM (CT) on September 8, 2021 and ends at 11:59 PM (CT) on September 15, 2021 (this is the “Promotion Period”). To enter, eligible entrants must comment on the Sweepstakes Facebook announcement post with their favorite book from their childhood (“Entry”).

All Entries become the property of Sponsor. Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities will be disqualified from participation in the Sweepstakes and all Entries from that individual will be considered void. Proof of submission will not be deemed to be proof of receipt by Sponsor. Sponsor is not responsible for any change of Facebook account status, email address, and/or telephone number of entrants.

2. **PRIZE(S):** Two (2) lucky winners will receive the prizes from Aconyte Books listed below:

3. **ELIGIBILITY:** Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of Entry who are registered members of Facebook. Employees of Fantasy Flight Games (“FFG”), its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “Promotion Entities”) and their immediate family members and/or those living in the same household of each are not eligible to participate.
