

FFG Arkham Nights 2020 Costume Contest – Official Rules

As part of the Arkham Nights 2020 event, Fantasy Flight Games is hosting an *Arkham Horror*-themed costume contest, referred to as the ‘Craftian Costume Contest.

What are the Prizes?

One lucky winner will receive an *Arkham Horror* Prize Package. This package includes the following:

- *Arkham Horror 3rd Edition – Dead of Night* expansion
- *Arkham Horror Dice Set*
- *Arkham Horror Dice Set – Bone*
- *Arkham Horror: Final Hour*
- *Arkham Horror: The Card Game – The Labyrinths of Lunacy* standalone scenario
- *Arkham Horror Novella – To Fight the Black Wind*
- Fantasy Flight Supply Dice Bag: Tentacles

Official Rules

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER.

HOW TO ENTER: The Arkham Nights 2020 Costume Contest (“**Contest**”) is an online-only Contest. Submissions for this Contest begin at 12:00:00 AM (CT) on 10/31/2020 and end at 11:59:00 PM (CT) on 11/1/2020 (this is the “**Promotion Period**”). To enter, eligible entrants must submit an image of themselves in costume to OrganizedPlay@FantasyFlightGames.com (“**Entry**”). This Entry must include the following:

- The entrant’s first and last name
- The name of the character they are dressed as

All Entries become the property of Fantasy Flight Games (“**FFG**”). Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple email accounts, or under multiple identities may be disqualified from participation in this and future Contests and all Entries from that individual may be considered void. Proof of submission will not be deemed to be proof of receipt by FFG. FFG is not responsible for any change of email address and/or telephone number of entrants.

ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry. Employees of Fantasy Flight Games, its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “**Promotion Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited.

WINNER SELECTION: One winner will be selected on or about 11/2/2020, from among all eligible Entries received during the Promotion Period by the judges in this Contest, whose decisions are final and binding.

WINNER NOTIFICATION: Potential prize winner(s) will be notified initially by a private message via email. FFG shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected. FFG, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.

Important: Sponsor may not be able to communicate with the entrant if the entrant does not submit to the correct email address. Sponsor is not responsible for changes to email (or any website or mobile application offered as part of such services), including any email functionality, that may interfere with a Promotion or ability of a participant to timely enter or otherwise participate. Sponsor is not responsible for misspellings, typographical errors, or other issues that may affect the ability of Sponsor to locate a purported Entry.

PRIZES, APPROXIMATE RETAIL VALUE, & ODDS: The winner will receive one (1) *Arkham Horror* Prize Package, as described earlier in this document. This package has an approximate retail value of \$133. Odds of winning depend on total number of eligible Entries received and the effort and quality of the costume presented, as perceived by the judges. Unclaimed prizes will not be awarded. All applicable federal, state, and local taxes on prizes are the sole responsibility of the prize winner. Limit one (1) prize per person in the Contest.

GENERAL: Potential winners must provide confirmation of mailing address as detailed in prize notification within ten (10) days after the first notification attempt. This must be a physical mailing address; PO boxes are not sufficient because a signature will be required on receipt. Failure to do so, and/or non-compliance with Official Rules may result in forfeiture of prize and an alternate winner may be selected. If prize notification or prize is returned as non-deliverable, prize may be forfeited. No correspondence will be acknowledged. No cash equivalents, substitutions or transfer of prize permitted. Subject to all federal, state and local laws/regulations. Acceptance of a prize shall be construed as and signify the winner's agreement and consent that FFG may use the winner's name, voice, likeness and/or prize information, without limitation, for promotional purposes without further consideration, review, approval or payment, unless prohibited by law. By participating, entrants and winners release and agree to absolve Promotion Entities, their respective parent companies, affiliates, directors, employees, officers and agents from any and all liability, injury, loss or damage of any kind, including but not limited to personal injury or death, arising from or in connection with participation in the Contest, or the awarding, receipt, possession, use or misuse of any prize and/or with respect to participation in any prize related activity. IDENTITY OF ENTRANT. All Entries must be submitted by the individual Entrant. Bulk or automated Entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at FFG's discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address on which the Entry is made. An "***authorized account holder***" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide FFG with proof that a potential winner is the authorized account holder of the account associated with the winning Entry.

LIMITATIONS AND RELEASES: Promotion Entities are not responsible for lost, late, mutilated or illegible entries nor for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions of or failure to receive entry information by FFG on account of technical problems or traffic congestion on the Internet or at any website and/or wireless network or any combination thereof. If for any reason the Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of FFG which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Contest, FFG reserves the right, at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify, or suspend the Contest, and to award the prizes from among all eligible non-suspect entries received up to the action taken by FFG, provided a sufficient number of eligible Entries have been received. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid

or illegal provision were not contained herein.
