

Twilight Codex Map Design Contest

As part of the upcoming Twilight Codex Vol. II, Fantasy Flight Games is hosting a *Twilight Imperium: Fourth Edition* map design contest!

What are the Prizes?

One winner will be chosen for each valid player count (3-player, 4-player, 5-player, 6-player, 7-player, and 8-player). The winner for each player count will have their map featured in the Twilight Codex Vol. II, as well as their name credited as the map designer. This contest can have a total of six (6) winners.

Official Rules:

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER.

How to Enter: The **Twilight Codex Map Design Contest** (“Contest”) is an online-only Contest. Submissions for this Contest begin at 12:00:00 PM (CT) on 12/28/2020 and end at 11:59:00 PM (CT) on 1/31/2021 (this is the “Promotion Period”). To enter, eligible entrants must submit their map design to ImperialCodex@FantasyFlightGames.com (“Entry”) with the subject line “Map Contest – X Players,” replacing “X” with their chosen player count (see below). This entry must include the following:

- The entrant’s first and last name.
- The player count they are submitting a map for (3-player, 4-player, 5-player, 6-player, 7-player, or 8-player).
- A filled-out map template (which will be provided by FFG).

Agreement to Official Rules: Participation in the Contest constitutes entrant’s full and unconditional agreement and acceptance of these Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein

Design Rules: First, choose a player count: 3-player, 4-player, 5-player, 6-player, 7-player or 8-player. There will be one winner for each player count. The winners’ maps will be published as part of the second volume of the Twilight Codex.

Using the appropriate template for your chosen player count—which can be found **online at** FantasyFlightGames.com - design your map while adhering to the following guidelines:

- A map can use any red- or blue-backed system tiles from *Twilight Imperium: Fourth Edition* and its *Prophecy of Kings* expansion.
- The nine hyperlane tiles can be used.
- A single system tile cannot be used twice, including hyperlanes—only one copy of each tile can be used.
- The map must be playable by all factions—home systems cannot be used in the map design.
- The map should adhere to the provided shape and must include Mecatol Rex as well as blank spaces for an appropriate number of player home systems but can vary in where

Mecatol Rex and those home systems are placed. Hyperlanes may also be used to achieve nonstandard adjacency and resource scarcity.

- Each person can submit a map for only one player count. Submissions beyond your first will not be considered.
- Winning map designs are at the sole discretion of the FFG game development team.

All Entries become the property of Fantasy Flight Games (“FFG”). Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple email accounts or under multiple identities may be disqualified from participation in this and future Contests and all Entries from that individual may be considered void. Proof of submission will not be deemed to be proof of receipt by FFG. FFG is not responsible for any change of email address and/or telephone number of entrants.

Eligibility: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry. Employees of Fantasy Flight Games, its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, “**Promotion Entities**”) and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited.

Winner Selection: One winner will be selected for each player count (3-player, 4-player, 5-player, 6-player, 7-player, and 8-player) on or about 2/15/2021, from among all eligible Entries received during the Promotion Period by the judges in this Contest, whose decisions are final and binding.

Winner Notification: Potential prize winner(s) will be notified initially by a private message via email. FFG shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected. FFG, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.

Important: Sponsor may not be able to communicate with the entrant if the entrant does not submit to the correct email address. Sponsor is not responsible for changes to email (or any website or mobile application offered as part of such services), including any email functionality, that may interfere with a Promotion or ability of a participant to timely enter or otherwise participate. Sponsor is not responsible for misspellings, typographical errors, or other issues that may affect the ability of Sponsor to locate a purported Entry.

Prizes, Approximate Retail Value, & Odds: The winner(s) will have their map design published as part of the upcoming Twilight Codex Vol. II, as described earlier in this document. This prize has an approximate retail value of \$1. Odds of winning depend on total number of eligible Entries

received and the balance, conduciveness, and overall quality of the map presented, as perceived by the judges. Unclaimed prizes will not be awarded. Limit one (1) prize per person in the Contest.

General: Acceptance of a prize shall be construed as and signify the winner's agreement and consent that FFG may use the winner's name, voice, likeness and/or prize information, without limitation, for promotional purposes without further consideration, review, approval or payment, unless prohibited by law. By participating, entrants and winners release and agree to absolve Promotion Entities, their respective parent companies, affiliates, directors, employees, officers and agents from any and all liability, injury, loss or damage of any kind, including but not limited to personal injury or death, arising from or in connection with participation in the Contest, or the awarding, receipt, possession, use or misuse of any prize and/or with respect to participation in any prize related activity. FFG is not responsible for any typographical or other error in printing, offering, announcement or administration of the Contest. By participating in this Contest, entrants agree to be bound by the Official Rules and the decisions of the judges, which are final and binding in all respects.

If participating in this Contest via your mobile device (which service may only be available via select devices and participating wireless carriers, and is not required to enter), you may be charged for standard data use from your mobile device according to the terms in your wireless service provider's data plan. Normal airtime and carrier charges and other charges may apply to data use and will be billed on your wireless device bill or deducted from your pre-paid balance. Wireless carrier rates vary, so you should contact your wireless carrier for information on your specific data plan.

Identity of Entrant: All Entries must be submitted by the individual Entrant. Bulk or automated Entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at FFG's discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address on which the Entry is made. An "***authorized account holder***" means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide FFG with proof that a potential winner is the authorized account holder of the account associated with the winning Entry.

Limitations and Releases: Promotion Entities are not responsible for lost, late, mutilated or illegible entries nor for electronic transmission errors resulting in omission, interruption, deletion, defect, delay in operations or transmission, theft or destruction or unauthorized access to or alterations of entry materials, or for technical, network, telephone equipment, electronic, computer, hardware or software malfunctions or limitations of any kind, or inaccurate transmissions or failure to receive entry information by FFG on account of technical problems or traffic congestion on the Internet or at any website and/or wireless network or any combination thereof. reserves the right to cancel, terminate, modify, or suspend the Contest if it determines, in its sole discretion, that the Contest is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other causes beyond FFG's control have destroyed, severely undermined, or to any degree impaired the integrity, administration, security, proper entry and/or feasibility of the Contest as contemplated herein. If for any reason the Contest is not capable of running as planned, including infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the control of FFG which corrupt or affect the administration, security, fairness, integrity, or proper conduct of this Contest, FFG reserves the right, at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify, or suspend the Contest, and to award the prizes from among all eligible non-suspect entries received up to the action taken by FFG, provided a sufficient number of eligible Entries have been received. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Caution: Any attempt by any person to deliberately damage any website or undermine the legitimate operation of the Contest is a violation of criminal and civil laws and, should such an attempt be made, FFG reserves the right to seek damages from any such person to the fullest extent of the law.
