

## Legend of the Five Rings 2021 Fan Art Contest – Official Rules

As part of the Battle of Cherry Blossom Snow event, Fantasy Flight Games is hosting a *Legend of the Five Rings* fan art contest.

### **What are the Prizes?**

Three (3) lucky winners will receive a *Legend of the Five Rings* Prize Package, which will be shipped after the official release of the *Under Fu Leng's Shadow* expansion. This package includes the following:

- *Under Fu Leng's Shadow* expansion
- All six Dynasty Packs of the *Temptations Cycle*\*:
  - *Twisted Loyalties*
  - *Honor in Flames*
  - *A Crimson Offering*
  - *The Temptation of the Scorpion*

### **Official Rules**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCE OF WINNING. YOU MUST HAVE INTERNET ACCESS TO ENTER.

**HOW TO ENTER:** The *Legend of the Five Rings* Fan Art Contest (“**Contest**”) is an online-only Contest. Submissions for this Contest begin at 12:00:00 AM (CT) on April 12, 2021 and end at 11:59:00 PM (CT) on May 7, 2021 (this is the “**Promotion Period**”). To enter, eligible entrants must submit a JPEG or PNG image of their art to [OrganizedPlay@FantasyFlightGames.com](mailto:OrganizedPlay@FantasyFlightGames.com) (“**Entry**”). This Entry must include the following:

- The entrant’s first and last name
- The entrant’s email address
- The title of the piece
- The art must depict characters, events, and/or locations relevant to FFG’s *Legend of the Five Rings* chronology
- The art cannot depict any graphic violence or sexuality

Entries will be judged based on the following criteria:

- Originality – 34%
- Style – 33%
- Effort – 33%

All Entries become the property of Fantasy Flight Games (“FFG”). Limit one (1) Entry per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple email accounts, or under multiple identities may be disqualified from participation in this and future Contests and all Entries from that individual may be considered void. Proof of submission will not be deemed to be proof of receipt by FFG. FFG is not responsible for any change of email address and/or telephone number of entrants.

ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older, or the age of majority in their state, at time of entry. Employees of Fantasy Flight Games, its parent company, affiliates, subsidiaries, partners, advertising and promotion agencies (collectively, "**Promotion Entities**") and their immediate family members and/or those living in the same household of each are not eligible to participate. All federal, state and local laws and regulations apply. Void where prohibited.

WINNER SELECTION: Up to three winners will be selected in a random drawing on or about May 12, 2021, from among all eligible Entries received during the Promotion Period by the judges in this Contest, whose decisions are final and binding.

WINNER NOTIFICATION: Potential prize winner(s) will be notified initially by a private message via email. FFG shall have no liability for any winner notification that is lost, intercepted or not received by a potential winner for any reason. If, despite reasonable efforts, a potential winner does not respond within forty-eight (48) hours of the first notification attempt, such potential winner will forfeit their prize and an alternate winner may be selected. FFG, in its sole discretion, will attempt to contact up to two (2) potential winners of a prize in accordance with the above procedure, after which the prize in question may go unawarded if it remains unclaimed. If any potential prize winner is found to be ineligible, or if he or she has not complied with these Official Rules or declines the prize for any reason prior to award, such prize will be forfeited, and an alternate prize winner may be selected.

Important: Sponsor may not be able to communicate with the entrant if the entrant does not submit to the correct email address. Sponsor is not responsible for changes to email (or any website or mobile application offered as part of such services), including any email functionality, that may interfere with a Promotion or ability of a participant to timely enter or otherwise participate. Sponsor is not responsible for misspellings, typographical errors, or other issues that may affect the ability of Sponsor to locate a purported Entry.

PRIZES, APPROXIMATE RETAIL VALUE, & ODDS: Each winner will receive one (1) *Legend of the Five Rings* Prize Package, as described earlier in this document. This package has an approximate retail value of one hundred and ninety-five USD (\$195.00). Odds of winning depend on total number of eligible Entries received. Unclaimed prizes will not be awarded. All applicable federal, state, and local taxes on prizes are the sole responsibility of the prize winner. Limit one (1) prize per person in the Contest.

GENERAL: Potential winners must provide confirmation of mailing address as detailed in prize notification within ten (10) days after the first notification attempt. This must be a physical mailing address; PO boxes are not sufficient because a signature will be required on receipt. Failure to do

so, and/or non-compliance with Official Rules may result in forfeiture of prize and an alternate winner may be selected. If prize notification or prize is returned as non-deliverable, prize may be forfeited. No correspondence will be acknowledged. No cash equivalents, substitutions or transfer of prize permitted. ***IDENTITY OF ENTRANT.*** All Entries must be submitted by the individual Entrant. Bulk or automated Entries will be disqualified (including entries made using any script, macro, bot, or promotional service). Multiple participants are not permitted to share the same email account. Any attempt to obtain additional entries through fraud or other illegitimate means will result in disqualification, at FFG's discretion.

In the event of a dispute about the identity of the entrant, entries will be declared made by the authorized account holder of the email address on which the Entry is made. An ***“authorized account holder”*** means the natural person who is assigned to an e-mail address by an Internet access provider, online service provider, or other organization (e.g., business, educational institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address. A potential winner may be required to provide FFG with proof that a potential winner is the authorized account holder of the account associated with the winning Entry.
