All Entries become the property of Fantasy Flight Games (“**FFG**”). Limit one (1) Entry per quiz question per person for the Promotion Period. Any entrant who attempts to enter more than once for the Promotion Period using multiple Facebook accounts, or under multiple identities may be disqualified from participation in this and future Sweepstakes and all Entries from that individual may be considered void. ELIGIBILITY: Open to legal residents of the fifty (50) United States and District of Columbia who are 18 years of age or older at time of entry and who are registered members of Facebook.
